



# **Activity-Status Update to the CRA Board**





### Business Development, Grant and Incentives Assistance

The Office of Economic Development (OED) conducted a CRA Business Grants Workshop on August 21, 2017 for eleven (11) attendees. One (1) Business Development Assistance Grant (rent assistance) was approved by the CRA Board at the August 24, 2017 meeting for Momaste Café' d/b/a as Family Yoga Zen Zone in the amount of \$6,000. The next two CRA Business Grants Workshops will be held on Monday, September 11 and Monday, October 10, 3:00 p.m. at the Greater Delray Beach Chamber of Commerce. #### **Business Attraction-Expansion-Retention Activity in August 2017**

Announced Projects:

Ioe Taylor Restoration completed a \$4.5 million renovation of their new 30,000 square foot headquarters facility on North Congress Avenue. Additionally, CareerSource Palm Beach County agreed to lease 1,091 square feet at 186 NW 5 Avenue and will employ five (5) workforce development professionals in their new location. Upper Cutz Barbershop and Salon, a Delray Beach start-up, is expected to launch with at least five (5) barbers and hair stylists when they open in October/November 2017 at 135 NW 5 Avenue.


